What is a Floodplain Management Plan?


- Flooding most frequent and costly natural disaster
- Floodplains are designated on FEMA Flood Insurance Rate Maps
- City of Rockport in the process of joining Community Rating System
- Plan analyzes the impact of flooding on the community and addresses goals, objectives, and actions to mitigate flooding
- Similar to a Hazard Mitigation Plan



Collaboration and Plan Development

- Rockport Mayor suggested making plan countywide
- Jurisdictions included:
 - City of Rockport
 - City of Aransas Pass
 - Town of Fulton
 - Aransas County
- Augmented existing Stormwater Management Advisory Committee into plan executive committee
- Subcommittees representing each jurisdiction

Organization (Chapter 2, Step 1)
